Wording changes to the DDO11 is proposed to occur through a separate amendment – C96.

Supports overlay being applied to remnant forest but requests removal of mapping from planted and self seeded native trees protected by landowner for future harvesting. 16	<b>(S14)</b> Allenvale Road, Lorne	Objection	Queries the exhibited extent of overlay and requests cleared areas be removed from mapping. <i>Note: submission was via counter enquiry where site visit was requested.</i>	Extent of bush on site discussed on site with landowner
17	<b>(S15)</b> Charas Road, Bellbrae	Objection	Objects to exhibited extent of overlay. Supports overlay being applied to large patch of native forest but requests removal of mapping from planted corridor of native trees.	Planted vegetation discussed on site with landowner

Concerned that overlay mapping may discourage landowners from planting native vegetation. Extent of remnant and planted vegetation discussed on site with landowner including tour showing other properties in the Deans Marsh/Pennyroyal area where extensive planting has also occurred over the past 20 years (Senior staff and Ward Councillors present).

20	<b>(S18)</b> Mirnee School Road, Winchelsea	Objection	Objects to overlay schedule being applied to native grassland. Submits there are other grasslands in the area that have not been mapped.	Extent of native grassland discussed on site with landowner and DELWP
21	<b>(S19)</b> Pennyroyal Station Road, Pennyroyal	Objection	Objects to application of overlays to planted vegetation. Submits that a small wetland on the property is the only part of the farm that could be covered by an overlay. Suggests further mapping be undertaken by suitably qualified professional. Supports protection of habitat and preservation of vegetation of environmental significance but requests removal of mapping from planted native trees. Landowner is part of the Otway Agro Forestry Network – see comments above under S16.
