#### **Summary**

In line with the Council resolution on 8<sup>th</sup> December 2015 interested parties were invited to attend a Hearing of Submissions on 2<sup>nd</sup> February 2016 to make a submission in person regarding the Winchelsea Recreational Vehicle (RV) Friendly Town project. Anyone wishing to do so needed to register their intention by Thursday 14<sup>th</sup> January 2016. It was not necessary for an interested party wishing to register to have been involved in the consultation phase conducted between 14<sup>th</sup> September and 5<sup>th</sup> October 2014.

A total of 13 registrations were received to make a submission comprising a mixture of local residents, groups and/ or associations, businesses and non-Surf Coast Shire residents.

#### 1.1 Winchelsea Recreational Vehicle RV Friendly Town

#### Report

#### Background

Growing Winchelsea Inc. collected 191 signatures on a petition between 17 February 2015 and 29 March 2015 requesting Council declare "Winchelsea an RV friendly town by allowing free camping along our beautiful Barwon River, thus attracting tourists and contributing to the economy of our town." The proposed site was on the Barwon River below the intersection of Mercer Street and Barwon Terrace, Winchelsea.

At the 23 June 2015 Council Meeting, Council resolved that further consultation must be done with the Winchelsea community in regards to an RV Friendly Parking area, in particular with the caravan park operator and surrounding land owners to the proposed site. A report on the consultation findings was requested at a Council meeting by December 2015.

A consultation and community engagement plan was created to invite comment from the surrounding landowners. Council officers prepared a draft design of a proposed RV Friendly Parking area on the Barwon riverbank, considered and addressed any perceived risks and prepared a plan for consultation.

In total 54 local residents and 51 external interested parties provided feedback on the proposed concept. A report on the findings was presented at the Ordinary Council Meeting on 8<sup>th</sup> December 2015. The report identified a mixed response to the proposed concept. At that meeting the following resolution was made:

That Council:

- 1. Defer item 3.6 Winchelsea RV Friendly Town Report Consultation to the Ordinary Council Meeting scheduled to be held on the 23rd February 2016.
- 2. Inform local Winchelsea residents, businesses, community groups, Growing Winchelsea Inc. and any other interested parties of the opportunity to make a submission in person on the Winchelsea RV Friendly Parking Area Proposal at a Council Briefing to be held in Winchelsea on the 2<sup>™</sup> February 2016. CARRIED 8:0

#### Discussion

A communication plan was created advising those involved to date in the process and other interested parties of the opportunity to verbally present at a Hearing of Submissions in Winchelsea on 2<sup>nd</sup> February 2016 between 4pm and 6pm. A total of 13 parties registered to present. A further interested party (local resident) initially requested to register, however was unable to attend on the 2 February and asked their opposition to the proposed location be recognised.

Interested parties wishing to register to make a submission need not have provided submissions or comments in the initial consultation process between 14<sup>th</sup> September to 5<sup>th</sup> October 2015.

The points raised in submissions will be considered in the overall assessment of the matter through a report on the original petition received from Growing Winchelsea Inc. to be presented at the 23<sup>rd</sup> February 2016 Council meeting.

Interested stakeholders could register to make a submission until Thursday 14<sup>th</sup> January 2016.

#### **Environmental Implications**

These aspects relating to the Winchelsea RV friendly proposal have been identified in the report provided to Council on the 8<sup>th</sup> December 2015.

The Hearing of Submissions process contains no environmental implications.

#### Communication

This is a Hearing of Submissions only and there will be no decisions made at this meeting in respect to this item.

Council will make its decision in relation to this matter at its Ordinary Council Meeting to held on Tuesday 23<sup>rd</sup> February 2016 after which all parties involved in the process will be advised of the outcome.

#### Conclusion
