No cover is available where the hire is part of a festival, event, street party or rock concert; b. The hire involves any activity that is deemed to be dangerous or high risk as determined by Council officers; c. Discuss with the Facility Hirer and where agreed select the check box on the 'Facility Booking Form' 3. Council and its Officers will not be liable for any thefts or losses incurred by the hirer, his agents or staff during occupancy or for any equipment remaining on the premises after the hire period.
