Citronella Collar and Outdoor Bark Control Conditions of Hire

USE OF THE OUTDOOR BARK CONTROL

The Outdoor Bark Control is small bird house and can be hung from a tree, fence etc, detects barking up to 50 feet away and only requires one small battery.

USE OF THE COLLAR

- The citronella collar is **not** to be worn in the water under any circumstances.
- Refills for the citronella collar are available at a cost of \$18.70 each.

DAMAGE OR LOST OF COLLAR OR OUTDOOR BARK CONTROL.

- If the collar or outdoor bark control is damaged, I understand I may be liable for the cost of replacement and repair. I will immediately notify Surf Coast Shire.
- If the collar or outdoor bark control is lost the hirer agrees to pay the full replacement cost of the unit.

RETURN OF THE COLLAR OR OUTDOOR BARK CONTROL

- The length of the hire agreement shall not exceed two weeks without calling the shire office to have an extension granted. If the collar is not returned by the specified due date, additional costs will be charges as per the weekly hire rate
- Additional cost for extending hire is \$22.65 per week.
- I will return the collar in a good clean condition on or before the due date

BREACH OF CONTRACT

- If I return the collar or outdoor bark control in a damaged condition, I will be liable to pay Surf Coast Shire the cost of any necessary repairs and replacement parts
- If I do not return the collar or outdoor bark control on or before the return date, Surf Coast Shire may contact me by telephone or at the address shown on this agreement to give me notice to return the collar. If I do not return the collar as per the instruction of Surf Coast Shire, the deposit for the collar will be retained by the Shire to recoup for the cost of the collar

INDEMNITY

I will indemnify Surf Coast Shire Collar Hire Scheme and their respective employees against all legal actions, suits, claims and demands arising out of the use of the collar which is contrary to this agreement.

CHANGE OF ADDRESS

I will immediately notify Surf Coast Shire if I change my address or contact details during the hire period.
