




Q2 We know different families (and cats) may have different preferences. Do you currently keep your cat(s) ...?





Q3 Have you personally experienced a cat nuisance issue during the last 12 months?









Q6 Thinking about the current cat rules for all areas, should Council consider a 24-hour cat curfew for...?




Q7 If the community and Council decide to move to a 24-hour cat curfew for all domestic cat owners, what time frame would be required for both you and your pet to transition?
