



## Conditions of Entry

- 1. It is a condition of entry that you must scan your membership card each time you enter Wurdi Baierr Stadium. The scan point is located at the front counter at reception.
- 2. Exercising and the use of equipment can be demanding and may have some inherent risk of injury. It is for this reason that as a condition of entry you acknowledge and agree that; the activities you undertake carry certain risks to your health, you are medically sound to participate in such activities and or have been cleared by a medical practitioner, you assume the risk and responsibility for any injury, illness, property damage resulting from your participation in any activity at Wurdi Baierr Stadium at any time.
- 3. Membership card sharing is viewed by Wurdi Baierr Stadium staff as theft of services from Wurdi Baierr Stadium and Wurdi Baierr Stadium Members and those found guilty will be fined \$150 per person.
- 4. At all times with no exception you must adhere to the following; wear appropriate attire, restack weights and equipment to allocated position after each use, use your own gym mat and wipe down equipment after use.
- 5. Any intentional damage to equipment or facilities will be charged to your account accordingly.
- 6. If your membership is expired, entry will not be permitted. Please contact staff at Wurdi Baierr Stadium to renew your membership.
- 7. You agree to be polite, courteous and respectful to all Wurdi Baierr Stadium members at all times.
- 8. Wurdi Baierr Stadium is somewhere people of all ages, genders, differing levels of physical fitness and conditioning can all exercise and improve their health and wellbeing in an inviting, friendly and safe environment. By signing to these terms, I agree to uphold these values and resultantly present and conduct myself in a manner that respects Wurdi Baierr Stadium, the Wurdi Baierr Stadium team, the fellow Wurdi Baierr Stadium members and myself.
- 9. I confirm that I am the person with lawful authority nominated on this Form. I will inform Wurdi Baierr Stadium immediately of any change to these details.
- 10. This agreement is legally binding whether my use of the facility and its services is determined on 12 month or 6-month basis or utilising the multi pass card system.
- 11. Memberships must be paid in full prior to commencement of the membership. Failure to pay the full fee of the membership upfront will mean the membership is deemed inactive and you will be unable to participate in classes until the membership is paid in full.
- 12. Fitness classes are fluid and are subject to timetable changes at management's discretion, given that the appropriate notice is provided to members.

- 13. On signing this agreement, you declare that you are physically fit and capable to engage in exercise and fitness programs at Wurdi Baierr Stadium. You are required to inform instructors of any condition that may have an effect on your ability to participate in any exercise prior to commencement.
- 14. You have the right to suspend your membership for a minimum of two weeks to a maximum of 3 months per calendar year provided that your membership is paid to date. A maximum of 2 suspensions can be applied in a calendar year
- 15. You agree not to sell or advertise your membership within any publication or website unless you have received written authorization to do so.
- 16. You are required to wear suitable clothing and appropriate enclosed sporting footwear in the Stadium. It is also important that personal hygiene is considered. It is appreciated that everyone wears deodorant, wipes down shared equipment after use and is aware of their own body odour.
- 17. We reserve the right to refuse entry to any person, including members, and have right to cancel your membership without warning or notice for serious inappropriate behaviour that is threatening or harassing, and includes damaging equipment and perceived risks.
- 18. You must keep us informed of any change of address, email address, contact numbers and any other information relevant to your membership
- 19. Any non-compliance to these terms will result in membership cancellation and will forfeit the remaining balance.
