"Bells Beach" Foreshore Reserve, Parish of Jan Juc.

With reference to previous correspondence, in particular your letter of 21st October 1965, regarding the formation of a Committee of Management to control the abovedescribed area, I wish to inform you that on receipt of a plan showing the exact area in question the necessary formal reports will be obtained.

In this regard I might mention that the southern boundary of the Torquay Foreshore Reserve (Rs. 1644) extends to the north-east corner of allotment 19, Parish of Jan Juc. Jarosite Road, as mentioned in your letter of 21st October 1965, cannot be identified on Departmental record plans.

In the interim, in auticipation of there being no objections to the proposal, the Chine President could be requested to convene a public meeting for the purpose of nominating four or five people as public representatives on the proposed Committee for a term of three years.

There would be no objection to the inclusion of a representative of your Council on the proposed Committee and I would be pleased to be advised of the full name of the Council's nominee.

A form of undertaking for signature by the persons nominated for appointment as public representatives, and also your Council's representative, and return to this office is enclosed.

With regard to the inclusion of the President of the Torquay Foreshore Reserve Co mittee of Management on the proposed Committee, I desire to advise you that a Committee of Management of a Crown Reserve can only spend its funds on the actual Reserve under its control in accordance with the provisions of Section 222 (1) (e) Land act 1958 (copy enclosed), and accordingly the Torquay Foreshore Reserve Committee would not be able to give any financial assistance to the proposed new Committee in regard to development works.

In the circumstances the inclusion of the President of the Torquay Foreshore Reserve Committee does not appear desirable or of any advantage.

However, there would be no objection to the Torquay Foreshore Reserve Committee assisting the proposed new Committee with advice and other practical assistance.

Any further comments you may care to make will receive due consideration, and on receipt of the required plan the whole matter will receive further attention.



Dear Sir, may I introduce myself as the newly elected secretary of the A.S.A. (Vic. Branch). Because of our fine showing, eg. roads, organization of the rally etc. the National Body of the ASA have voted 7: 2 in favour of the 1967 National Titles to be held in Victoria.

The Committee favour Bell's Beach at Easter time to be the venue for the titles. However, we will have to assure the National Body that adequate facilities will be provided before the National Body will accept Bell's Beach as the venue.

The last Bell's Beach rally attracted an astonishingly large crowd, considering that we had had no publicity. (Our Publicity Officer 'vanished').

Proper publicity, for a National Titles Carnival, will multiply spectator attendance. I would not be surprised to see 10,000 or more people there.

Dear Sir,

Thank you for your letter of 7th July relating to the Bells Beach area, this matter was considered by Council at its last meeting.

The Shire President will be holding a public meeting shortly to form a Committee of Management for the Bells Beach area, and once this has been done you can expect that toilet blocks and other facilities will be constructed. As a matter of interest the Council has already done test borings for water for the proposed toilet block, and a grant has been applied for to the Tourist Development Authority to construct the toilets. The Council realises that this beach is one of the best surf beaches in the world and will endeavour to improve the facilities for the ever increasing number of people who visit the area. The main problem of course is finance and the Council was wondering whether your Association would be prepared to contribute towards the cost of the toilet block. While the Government makes available a substantial grant, there must be a local contribution to match the grant, and in this case it would be possibly \$1,000.

If you could advise me of the attitude of your Committee on this matter before 5th August, I feel that this would considerably help the situation.

I have not been able to bring the matter regarding financial assistance from our Association to the attention of the Committee; our next meeting will not be held till August 24.

However, on an unofficial basis, I am personally most eager to try anything that may result in a toilet block by Easter 67, in time for the National Champtonships. And with the right approach I should be able to talk the Committee into any plan of action that we might agree to.

Financial assistance from our Association would have to come after special fund raising activities, specifically for the purpose of amenities at Bell's Beach. Our Membership fee of \$1.00 per year just covers the Membership Administration cost. Trophies, Teams Funds etc. are raised by special effort.

Who then would support a drive for funds to be raised for Bell's Beach as such, and for the 1967 National Championships in particular?

Firstly, Surfers would support Raffles, Barbecues, Film nights, dances etc. I could organize something here. Secondly, the General Public, if properly approached, MIGHT support a direct appeal. Motorists passing through Geelong, Torquay or Anglesea might donate into collection boxes; they might buy raffle tickets in Milk Bars etc. Perhaps the Geelong JCC could organize something in conjunction with your Shire.



I attach communication I have received from the Shire of Barrabool in relation to the abovenamed area, which is self explanatory.

The problem of financing the development of new surfing beaches is an increasing one being brought about by greater numbers of people now becoming interested in this form of recreation.

The suggestion that Committees of Management for foreshore and camping areas adjacent to surf beaches being opened up should take a financial interest in those areas, would appear to have a certain amount of logical argument.

It is obvious that campers in the established areas will patronium these never areas which in many cases are in reasonably close proximity to their camping sites.

I believe that the problem of financing these never areas is an argent one, and would marit some consideration being given by the Government to investigating ways and means of providing some measure of additional financial assistance to Committees of Hanagement who would agree to an extention of their existing boundaries.



The Secretary, Barrabool Shire Council, has asked me to address all correspondence in connection with Bell's Beach to you. I realize your Committee is not yet the official controlling body of the Bell's area, but complying with the Barrabool Shire's request I write to you.

Firstly, I wish to thank you for your efforts towards better amenities in the Jan Juc to Point Addis area both from the Asa's point of view and my own; both my wife and I sincerely appreciate what has been done and what is proposed. 





Thank you for your letter containing the addresses of the Councillors; I shall be sending out Official Basses as soon as I get them from the Printers.

I am sorry that I did not write this confirmative letter regarding the arrangements and preparation of Bell's Beach for the Nationals eardier, but I caught a 'wog' which laid me low for some days...

Most of us feel somewhat powerless against the mentality of thieves who will cause many hundreds dollars worth of damage for relatively little gain. I went down to Bell's myself, and I am convinced that this was a planned theft; quite clearly, a boltcutter, or similar tool was used to open the back door, and the same tool probably cut through all the copper tubes. The question now is, what can we do to help.

Money we have not got at this stage. However, at least the senior Committee Members want the ASA to contribute as much as we can, as soom as we can.

Advice may perhaps not be wanted, but if it is, we are prepared to come along and discuss what can be done.

On my own initiative I wrote the correspondence attached as item No 2. Whilst I do not expect much help from the Police, I will write to them as suggested by the Law Department.

II) Balance of bill. I trust that our new treasurer, Mrs. A. Saunders sent you our cheque in time for inclusion in your Sept. 30th Balance Sheet. We did find the money needed for the balance.

III) Contests at Bell's Beach. Item No 3 attached, is a list of rallies planned at this stage. The two biggest rallies are planned for Bell's Beach, and I herewith apply for permission to hold these two rallies. We are hopeful of a big financial success; expenses should be much, much lower and from past mistakes we hope to have learned how to increase our revenue:





Report of Interview - Bells Beach

Date - 11th December, 1970.

Present Crs. Pettitt, Purnell, McIntyre, Shire Secretary, Assistant Engineer, Health Inspector, Messrs. Couper, Brookes and other representatives from the Australian Surfriders' Association.

Discussion

After general discussion about the futute control and development of the area, the following recommendations were made by the Australian Surfriders' Association.

- 1. That the Council request the Lands Department to form a Committee of Management for the area bounded by Bones Road and Jarosite Road.
- 2. The area be known as "The Bells Beach Surfing Recreation Reserve".
- 3. That the Council be Committee of Management and that a sub-committee be formed to control the day by day affairs of the Reserve, comprising the three Moriac Councillors for the time being and three persons from the Australian Surfriders' Association.
- 4. That in principle the area be left in its natural state, rather than encourage commercial development.
- 5. That the Soil Conservation Authority be requested to report on conservation measures.
- 6. That a native flora reserve be planted.
- 7. That areas be fenced off and developed into flora areas, and that defined picnic areas be established.
- 8. That signs be erected advising that the area is the Bells Beach Surfing Recreation Reserve.
- 9. That traffic counts be taken to establish popularity of the area.
- 10. That when the Australian Titles are held in Easter 1971, the State Minister for Tourism be invited to attend, and that the area be officially opened as the "Bells Beach Surfing Recreation Reserve".
- 11. That the Superintendent of Barwon Police District be requested to have the area patrolled at weekends to try and combat vandalism.

The area known as Bells Beach has become remarkably popular with surf board riders in the last few years, and in the early 1960's, the Council formed a rough track to the Beach, after being requested by a number of ratepayers. Twelve months later, the Council constructed Bones Road and improved the access road and from them on many thousands of people came to the area.

Facilities were then required, and in 1967 the Council with the assistance of a Tourist Development Authority Grant constructed a toilst and shower block worth \$10,000. The Council also began to provide beach cleaning and toilst maintenance facilities.

Popularity of the area continued to grow and in 1968, the Australian Titles were held at the Beach, and further amenities were provided. It was obvious to the Council that the area was becoming very popular and that further land was needed, and steps were taken in 1969 to acquire 42 acres adjacent to Bells Beach for tourist purposes. The Council gained title to this land in 1970.

Also in 1970, the World Surfing Titles were held at the Beach, and with State Government assistance, \$40,000 was spent sealing roads and constructing a scenic drive from Bones Road to Jarosite Road. The visitors from overseas were most impressed with the Beach and the fact that it was still relatively unspoiled and in a natural state.

In December 1970, the Council met with representatives of the Australian Surfriders' Association and agreed to request your Department to appoint the Council as Committee of Management for that area of Crown Land bounded by Jarosite Road and Bones Road (Map enclosed)

The Council considers it would be logical for this to occur, as the whole area including the 42 acres owned by the Council could then be properly controlled and conserved. It is intended to develop native flora areas, create flora reserves, and generally return the matural environment of the area.

If possible, this Council and the Australian Surfriders' Association would be pleased if the area could be known as the "Bells Beach Surfing Recreation Reserve".

At present most of this area is under the control of the Torquay Foreshore Committee, and the Council understands the Committee would have no objection to this proposal.
